Methodological notes

The process of town promotion had passed a long-term historical progress. The population as of 31st December of given year is computed as the population as of 31st December of last year plus natural increase (live births minus deaths) and net migration (immigrants minus emigrants). It is not true for years in which the population census was done. Here it refers to the stock as of 31st December 2001 that follows the Population and Housing Census (1st March 2001) results and not follows the stock as of 31st December 2000.

Besides natural increase and migration the changes in numbers of inhabitants are referable to merging or separating of municipalities or their parts. The administrative changes concerning here-published towns are stated in the next table.

All data refer to the residents of the towns irrespective of citizenship. Since 2001, the figures also include (in accordance with the Population and Housing Census 2001) foreigners with long-term stay (i.e. the stay based on visa over 90 days, as stipulated by Act No. 326/1999 Coll.) and foreigners with granted asylum status (in compliance with Act No. 325/1999 Coll.). Since 1st May 2004, in accordance with amendment No. 326/1999 Coll., the figures include citizens of the European Union with temporary stay on the territory of the Czech Republic, and citizens of other countries with long-term stay. The data contain also information on events (marriages, births and deaths) of permanent residents of CR that occurred abroad.

All data concerning 'age' always refers to completed age. The dependency ratio is the number of persons aged 65 and over per 100 persons aged 0-14.

Marriages are included into Towns according to the permanent residency of the groom, **divorces** are included according to the last common residency of spouses, **births** according to the permanent residency of mother and **abortions** according to the permanent residency of woman.

Exact definition live birth, stillbirth and abortion as indicated in publication Demographic Yearbook of the Czech Republic (code 4019-06).

The numbers of deaths by causes were classified according to the 10th decennial revision of the International Statistical Classification of Diseases and Related Health Problems (ICD-10).

Migration is the change in a municipality of residence within the territory of the Czech Republic or across the borders of the Czech Republic (external migration).

Natural increase is the difference between the numbers of live birth and deaths; net migration is the difference between the numbers of immigrants and emigrants. Total increase is the aggregate of the natural increase and the net migration.
