

Methodological notes of external trade in goods according to the movement (the cross-border concept)

This publication contains data on external trade of the Czech Republic in total and by group of countries by the Classification of Products by Activity, 2008 version (CPA 2008).

The cross-border concept of external trade reflects only physical movements of goods across the border regardless of whether the trade between the Czech and foreign entities occurs. These data are internationally comparable and can be used as indicators of development of value of the trade.

The source of data on external trade according to the movement is information collected by customs authorities. Starting from processing of the January 2004 data, data collection and the first check are carried out by the Customs Administration of the Czech Republic, whereas the Czech Statistical Office is in charge of further data processing, checks and publishing.

In compliance with the binding regulations of the EU, the measurement of data on exports and imports is governed by Customs law No. 242/2016 Coll., from 14 July 2016. Intrastat is governed by Government regulation No. 244/2016 Coll. from 18 May 2016 implementing several provisions of Customs law in the scope of statistics.

The cross-border concept of external trade in goods is made up of the sum of intra-Community trade (trade with the EU Member States) and trade with non-EU countries. Data on goods traded between Member States of the Communities are supplied by reporting units to the customs office on the Intrastat forms, with information on dispatches of goods or arrivals of goods. Data on imported and exported goods in trade with non-EU countries are given in a Single Administrative Document.

Data on exports are compiled by country of destination and data on imports are compiled by country of origin.

Data on external trade in USD and in EUR are calculated, using average monthly exchange rate in a given period as reported by the Czech National Bank.

Notice

Starting with publishing data for 1st quarter 2017, this publication will newly contain data on external trade in the national concept according to the Classifications of Products, 2015 version.

The national concept of external trade reflects export and import performance of the Czech economy, i.e. the external trade balance of the Czech Republic as well. It measures real trade in goods carried out between the Czech and foreign entities, i.e. a change of ownership between residents and non-residents.

Data on external trade in goods by CZ-CPA in the cross-border concept will be provided only through the Information Services Section of the CZSO.

The data for individual months of 2015 are final. The data for individual months of 2016 are preliminary. 2016 data of the reference month are released together with updated data of the previous three months.

Casual differences on the last digit position arise from rounding off the absolute number.
