Principal agricultural activity according to typology classification

Specialist field crops:	cereals, oilseeds and protein crops represent more than 2/3 of total SGM or field crops represent more than 2/3 and cereals less than 2/3 of total SGM.
Specialist horticulture:	garden crops represent more than 2/3 of total SGM.
Specialist permanent crops:	vineyards or fruit orchards or various permanent crops represent more than 2/3 of total SGM.
Specialist grazing livestock	dairying or rearing and fattening of cattle or cattle represent more than 2/3 of total SGM or sheep, goats and various grazing livestock represent more than 2/3 of total SGM.
Specialist granivores:	pigs, poultry and various granivores represent more than 2/3 of total SGM.
Mixed cropping:	garden crops represent more than 1/3 and permanent crops more than 1/3 of total SGM or field crops represent more than 1/3 and other activity does not exceed more than 1/3 of total SGM.
Mixed livestock:	cattle rearing represent more than 1/3 and less than 2/3 and other activity does not exceed more than 1/3 of total SGM or pigs and poultry rearing represent more than 1/3 and less than 2/3 and other activity does not exceed more than 1/3 of total SGM.
Mixed crops - livestock:	field crops represent more than 1/3 and cattle rearing represent more than 1/3 of total SGM or there is no predominating activity.

Classification is published in a simplified way. It's full version is a part of Commission Decision 85/377/EC.
