



Trends in producer price indices in Q2 2025

In Q2 2025, compared to Q1 2025, agricultural producer prices went up by 3.9%, and were higher by 14.9% year-on-year (y-o-y) in Q2 2025. In Q2 2025, compared to Q1 2025, industrial producer prices were lower by 1.5 %, and fell by 0.9% y-o-y in Q2 2025. Construction work prices rose by 0.8% in Q2 2025 compared to Q1 2025, and were 3.2% higher y-o-y in Q2 2025. Service producer prices in the business sphere grew by 2.3% in Q2 2025 compared to Q1 2025, and were 4.2% higher y-o-y in Q2 2025.

In **Q2 2025**, compared to **Q1 2025**, **agricultural producer prices** were higher by 3.9%. Rising were prices of cattle for slaughter (+13.0%), eggs (+7.9%), pigs for slaughter (+4.5%), poultry (+3.6%) and cereals (+2.1%). Prices of oilseeds and milk grew equally (+2.8%). **Agricultural producer prices** increased by 14.9%, **y-o-y**, in **Q2 2025**. Prices in crop production grew by 14.7% due to higher prices of fruit (+28.3%), oilseeds (+24.3%), cereals (+14.9%) and fresh vegetables (+6.9%). Prices of potatoes went down (-23.8%). Prices in animal production increased by 15.6%. Prices of eggs (+41.8%), cattle for slaughter (+28.0%), milk (+19.7%) and poultry (+6.0%) rose. Prices of pigs for slaughter were lower by 9.8%.



In **Q2 2025**, compared to Q1 2025, **industrial producer prices** were lower by 1.5%. Prices fell primarily in 'coke, refined petroleum products'. Prices decreased in 'crude petroleum and natural gas' (-6.6%), 'electricity, gas, steam and air conditioning' (-5.1%) and 'chemicals and chemical products' (-4.2%). On the increase were prices in 'wood and of products of wood and cork, except furniture' (-3.2%) and 'other mining and quarrying products' (+1.6%). Prices rose in food products' and 'rubber and plastic products' (+1.2% both).



In Q2 2025, industrial producer prices were lower by 0.9% **y-o-y** (in Q1 2025 they stayed unchanged). Prices decreased markedly in 'coke, refined petroleum products'. Lower were prices in 'crude petroleum and natural gas' (-16.8%), 'coal and lignite' (-10.4%) and 'chemicals and chemical products' (+7.1%). Prices grew in 'other mining and quarrying products' (+6.2%), 'wood and of products of wood and cork, except furniture' (+4.9%) and 'wearing apparel' (+4.7%).



ANALYSIS

In **Q2 2025**, according to the estimate, **construction work prices** compared to **Q1 2025** (after updating) were higher by 0.8%. Prices of construction materials and products input rose by 0.5%. **Construction work prices**, as estimated, grew by 3.2% in **Q2 2025** compared to **Q2 2024** (after updating). Prices of construction materials and products input increased by 0.9%, **y-o-y**.



In Q2 2025, compared to Q1 2025, service producer prices in the business sphere rose by 2.3%. On the increase were prices in 'programming and broadcasting services' (+23.6%), 'advertising and market research services' (+21.4%), 'employment services' (+5.2%), 'motion picture, video and television programme production services, sound recording and music publishing' (+4.8%) and 'security and investigation services' (+2.4%). Service producer prices in the business sphere, excluding advertising services, went up by 0.9%. Service producer prices in the business sphere grew in total by 4.2%, y-o-y, in Q2 2025. Prices in 'programming and broadcasting services' (+18.8%), 'advertising and market research services' (+14.8%), 'security and investigation services' (+12.5%) and 'employment services' (+10.1%) were higher. Service producer prices in the business sphere, excluding advertising services, grew by 3.3%.

Note: For internal reasons, the Czech decimal comma is used instead of the English decimal point as a decimal separator in tables of this analysis.
